10 YEAR LIMITED WARRANTY

Daylighting Systems frp panels as manufactured by Kemlite Company, Inc., Florence Sales Office, 8015 Dixon Drive, Florence, KY 41042 or by Kemlite Company, Inc., Grand Junction Sales Office, P.O. Box 569, Grand Junction, TN 38039 are warranted for a period of ten (10) years from the date of purchase to be free from substantial defects in materials and workmanship. This warranty is extended only to the original purchaser and is non-transferable. Panels covered under this warranty are warranted for a period of ten (10) years from date of purchase to:

1. Be free from substantial defects in materials and workmanship.
2. Not rot, rust, corrode, or develop structural surface cracks.
3. Be equal to or exceed the applicable requirements of the Standard Specification for Glass Fiber-Reinforced Polyester Plastic Panels, ASTM Designation D 3841.

Upon documentation and verification of defect or failure, the above referenced product will be repaired or replaced, without charge if it fails due to the above defects. This warranty does not include labor costs or miscellaneous costs for removal and/or replacement.

The warranty applies only to panels stored, applied, installed and used in accordance with manufacturer's recommendations and technical bulletins and with recognized standards of construction. This warranty does not cover defects caused by:

1. Improper installation (non-conformance with recognized standards of construction). Failure due to any adhesive, caulk or other accessory.
2. Damage (not resulting from defects) while in possession of the customer.
3. Unreasonable use (including failure to provide reasonable and necessary maintenance). Normal pigmentation fading or abnormal fading due to exposure to ultraviolet rays. Damage or loss due to acts of God, improper storage, catastrophic events such as fire, hurricane, or flood.

Kemlite Company, Inc. disclaims any warranty, expressed or implied, which is not contained herein, including any implied warranty of merchantability or fitness for a particular purpose. Kemlite Company shall not be liable for consequential, incidental or punitive damages.

This warranty is the sole warranty provided for Daylighting Systems frp panels and replaces all previous warranties.
